As such, we work to engage all stakeholders when it comes to the continuous learning of our students. Stakeholder feedback was solicited through several different formats which included listening to student, teacher, family, and community perspectives and input.

CAT teachers and staff regularly review student data and develop plans to support students to meet academic and social-emotional expectations in partnership with students, their families, and community. CAT students and teachers participated in network-wide student and teacher committees to reflect on patterns of student needs, and give input on critical strategies to address student needs and goals. CAT families participate in student-led conferences and family meetings to support effective school and family partnerships in response to student needs. Each engagement provided valuable insight into the diverse student needs at CAT, and stakeholders' ideas for meeting those needs in responsive ways.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
